

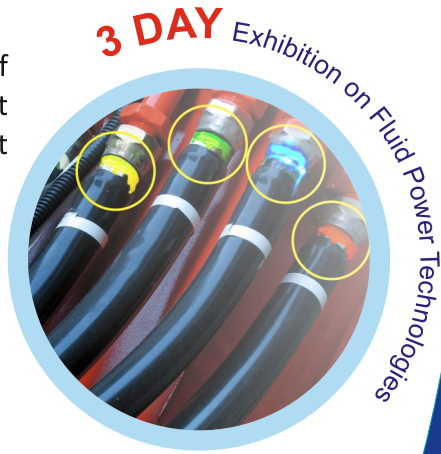
THE EVENT

- High Efficiency Solar PV Modules (Rs 4,500 crore)
- White goods (Rs 6,238 crore) and
- Speciality Steel (Rs 6,322 crore).
